MINUTES OF A SPECIAL MEETING OF THE COMMISSIONERS OF THE HOUSING AUTHORITY OF THE BOROUGH OF HIGHLAND PARK



The Commissioners of the Housing Authority of the Borough of Highland Park met in a Special Session in the Community Room of the S.J. Kronman Apartments located at 242 South Sixth Avenue, Highland Park, NJ at 12:00 PM on May 24, 2018, the hour and date duly established for the holding of said meeting.

The meeting was called to order by Chairman Chudnick.

RESOLUTIONS

 a) Reso #2018-27 – Award Contract for RAD Improvements at the Samuel J Kronman Building

Motion moved by Commissioner Sedehi and seconded by Commissioner Methven to adopt Resolution #2018-27.

Discussion

Executive Director Brightman explained that prior to this resolution the BOC had awarded and then rescinded a resolution for the bathrooms and vents. Due to a defect in the bid process and NJHMFA not allowing the HPHA to perform RAD work, the specifications were re-written and re-bid. Two of the three bidders submitted new bids.

Commissioner Monk expressed a concern about being sued by the former bid awardee. He also expressed a concern about the large difference in pricing between the two bidders.

Executive Director Brightman stated that the A/E reviewed the bid submitted by Santorini and recommended their selection stating it was within their cost estimates.

Commissioner Reh inquired as to the price difference as well.

Commissioner Methven commented that sometimes bidders increase their pricing on federally funded jobs.

Discussion

Commissioner Monk stated that he wanted clarification on how much of the bill was due to extra work versus a price increase noting that once a bid is accepted that is the price.

Commissioner Methven stated that extra materials were required due to the type of windows.

Commissioner Sedehi asked if the change order was for the doors as well.

Executive Director Brightman responded, no, just the windows. She stated that she would address Commissioner Monk's concern. She also stated that the A/E reviewed the change order and approved it.
