RESOLUTIONS

a) Reso #2018-38 – Award Change Order #1 for the Roof Replacement at Samuel J. Kronman in the Amount of \$55,318.00

Motion moved by Commissioner Monk and seconded by Commissioner Rainwater to adopt Resolution #2018-38.

Discussion

Commissioner Reh inquired about the specification/code change.

Executive Director Brightman stated that the architect that prepared the roof specs is Element Architectural Group. After the specifications were prepared the code changed, specifically, the energy code which requires additional insulation on the roof. Element revised the existing roof specs and the roof contractor priced the change which resulted in our increase of \$55,318.00.

Commissioner Monk asked if there was still a contingency fund in the budget.

Susan Lenz replied, yes.

Commissioner Martinez stated that she felt this was a large increase in the price and she would have preferred to see a timeline from the architect that documented when the specs were prepared and when the code changed. She further stated that if the Executive Director felt comfortable with the change, she would agree to it.

Executive Director Brightman stated that both she and Maintenance Director Stecker reviewed the code change. She went on to say that the specs were in fact prepared before the code change as she researched it herself. She further added that Element could have informed the Authority of the change sooner than they did.

Commissioner Methven stated that in his work, at the church, he sees code changes on a regular basis.

Commissioner Reh stated that she agreed with Commissioner Martinez that she would have liked to see more of an explanation of the change from the Architect as the roof specs were not easy to decipher.

Executive Director Brightman stated that she agrees and added that we have been requiring a lot of paperwork from our A/E's and contractors on behalf of NJHMFA and they have really all gone above and beyond in the process so she did not want to push the issue.

Commissioner Monk mentioned that the RAD Committee met prior and the idea of having the RAD Committee transition into a finance committee was discussed.
