Counsel Corriston congratulated the Board on the Kronman RAD closing.

Executive Director's Report:

Executive Director Brightman reported that Kronman closed on April 4th. However, not all the insurance requirements have been met, so we cannot start construction. She further stated that the construction contracts are at least two years old and that we need to see what increases have occurred such as material increases and Davis Bacon wage rates. We do have a contingency line item but we need to see the new contract amounts as work may need to be delayed to subsequent years.

The Executive Director informed the BOC that a new regulation was just published that allows for a conversion without going through all the hoops that we incurred. She stated that it would be interesting to see what we could have borrowed with the new regulations and whether or not it would have been necessary to obtain low income tax credits.

Executive Director Brightman stated that the Kronman LP Board will be in charge of the rehabilitation work. She further noted that the BOC may want to establish a committee that reports on the work.

Executive Director Brightman stated that Mayor has not yet replaced Don Monk.

Executive Director Brightman reported that she inspected the bathroom work being done at Park Terrace and showed the pictures of a completed bathroom.
