## AWARD CONTRACT FOR ELECTRICAL REPAIR CONTRACTOR TO LOU'S ELECTRIC CO. FROM 2/1/18-1/31/20

**WHEREAS**, the Housing Authority of the Borough of Highland Park, New Jersey (Authority) needs to establish an electrical repair service contract with a qualified Electrical Contractor; and
